How to Vote on the Item of Business

Each CHESS Depositary Interest (CDI) is equivalent to one share of Company Common Stock, so that every 1 (one) CDI registered in your name at 6:00 a.m. (Australian Western Standard Time) on Tuesday, November 4, 2025 (5:00 p.m. (Eastern Time) on Monday, November 3, 2025) entitles you to one vote.
