

## NOTICE OF PRESENTATION

### **(FINAL ORDER)**

**TAKE NOTICE** that the present *Application for the Issuance of an Interim Order and a Final Order in connection with Robex Resources Inc.'s Proposed Arrangement* (the “**Application**”) will be presented for adjudication of the Final Order before the Honourable Jean-François Émond, J.S.C., sitting in commercial division for the district of Québec on **January 13, 2026, at 9:30 a.m.** (Eastern time) or so soon thereafter as counsel may be heard (the “**Final Order Hearing**”), at the Québec Courthouse, located at 300 Jean-Lesage Blvd, Québec (Québec), G1K 8K6, in a room to be communicated by the Court to the Applicant’s counsel who shall forthwith communicate them to counsel to Predictive and Acquireco, to the AMF, and to all persons who have filed and served an appearance pursuant to the Interim Order issued by the Court on November 11, 2025 (the “**Interim Order**”).

Pursuant to the Interim Order, if you wish to appear and be heard at the Final Order Hearing, you are required to file and serve upon the following persons a notice of appearance in the form required by the rules of the Court, and any affidavits and materials on which you intend to rely in connection with any submissions at the hearing, as soon as reasonably practicable and by no later than 4:30 p.m. (Eastern time) at least five (5) business days immediately preceding the date of the Final Order Hearing: counsel to the Applicant, Osler, Hoskin & Harcourt LLP (Attention: Mtre. Fabrice Benoit and Mtre. Jack M. Little), either by fax (514-904-8101) or email ([FBenoit@osler.com](mailto:FBenoit@osler.com) and [jlittle@osler.com](mailto:jlittle@osler.com)), with a copy to Predictive and Acquireco by service upon counsel thereto, Fasken Martineau DuMoulin LLP (Attention Mtre. Brandon Farber), either by fax (514-397-7600) or e-mail ([bfarber@fasken.com](mailto:bfarber@fasken.com)).

If you wish to contest the Application, you are required, pursuant to the terms of the Interim Order, to serve upon the aforementioned counsel to the Applicant, with copy to counsel to Predictive and Acquireco, a written contestation, supported as to the facts alleged by affidavit(s) and exhibit(s), if any, by no later than 4:30 p.m. (Eastern time) at least five (5) business days immediately preceding the date of the Final Order Hearing.

**TAKE FURTHER NOTICE** that, if you do not file an answer (notice of appearance) within the above-mentioned time limits, you will not be entitled to contest the Application or make representations before the Court, and the Applicant may be granted a judgment without further notice or extension. If you wish to make representations or contest the issuance by the Court of the Final Order, it is important that you take action within the time limits indicated, either by retaining the services of an attorney who will represent you and act in your name, or by doing so yourself.
